

**REQUEST FOR PERMIT TO KEEP LIVESTOCK WITHIN
THE CORPORATE LIMITS OF THE CITY OF WASCO**

As stated in the City of Wasco Nuisance Ordinance No. 325, Section 41, Livestock:

No livestock shall be maintained, kept, or housed within the corporate limits of the City, except as approved by the City Council on a case-by-case basis.

For the purposes of this section, the following definitions apply:

1. "Livestock" includes, but is not limited to, horses, mules, cattle, sheep, hogs, goats, llamas, alpaca, rabbits (including hares), and fowl (including turkeys, chickens, geese, ducks, emus and ostriches).

2. "Exceptions" include:

- (a) A total of 6 (six) or fewer laying hens may be kept on any one City lot;
- (b) A limit of 1 (one) rabbit may be kept per household, for a period of six months or less, to be used for 4-H projects only;
- (c) Other exceptions as approved by the City Council after proper application and hearing.

It is unlawful for any person to maintain, keep, or house livestock on any property within Wasco City limits unless issued a permit to do so. In the case of rental residential property, written permission must be given by the property owner for a tenant to keep livestock on said residential premises.

The applicant named above is requesting a permit to keep the following specific livestock:

No person shall maintain a shelter or pen unless granted a permit by the City. The permit shall be subject to all terms and conditions of Wasco Nuisance Ordinance No. 325 and any additional conditions deemed necessary by the City. The permit shall be granted or denied by the Wasco City Council after review of an application that includes a diagram indicating the location of the shelter and run, and the approximate size and distance from other structures and property lines. (No shelter or run shall be located within 25 feet of a residence or building on an adjacent property). **The applicant must also obtain written approval for the keeping of livestock (as named above) from all owners of property within 100' of the permit address.**

Instructions to abutting property owners: Your neighbor is applying for a permit to keep livestock. If you are an abutting property owner, your consent to this permit is required for issuance. By signing this form, you are providing written consent for the issuance of the permit. **Do not sign this form if you are NOT giving consent to the issuance of a permit.**
